

USER AGREEMENT for centerlab.pro

This Agreement governs the use of centerlab.pro, owned by Limited Liability Company “CENTER LAB”.

1. Terms

Website means the website available at <https://centerlab.pro/>, including all of its sections, pages, materials, forms and services.

Website Owner means the Operator identified in Section 2 of this Agreement.

User means any person who accesses the Website and uses its materials or forms.

Website Materials means texts, images, graphics, logos, presentations, studies, news, publications, the Website structure and design, and other content available on the Website.

3. Acceptance of the Agreement

Use of the Website constitutes the User’s acceptance of this Agreement to the extent applicable to ordinary browsing and use of Website Materials.

4. Status of Website Information and No Public Offer

Optional cookies and analytics services are used in accordance with the user's choices in the cookie banner, the Website settings and applicable law.

10. Links to Third-Party Resources

The Website contains links to external resources. The Website Owner does not control the content or privacy policies of such resources or the actions of their owners and is not responsible for their operation, except where otherwise provided by law.

11. Limitation of Liability

The Website Owner endeavours to keep the information accurate and up to date but does not guarantee that the Website will be free from technical errors or interruptions or that the materials will be fully applicable to the User's particular circumstances.

The User uses the Website at their own risk. The Website Owner is not liable for losses resulting from misuse of information on the Website, technical failures, third-party actions or force majeure, except where liability is imposed by law.

12. Amendments to the Website and Agreement

13. Dispute Resolution

The parties will seek to resolve disputes through negotiation and a written claim.

If a dispute cannot be resolved through negotiation, it will be submitted to a court having jurisdiction under the laws of the Russian Federation.
